What is Equivalence?



Equivalence exists when the outcomes of two processes are directly comparable even though the paths to achieving them are different.



When equivalence is shown to exist between a new qualification and the qualification or experience an individual already has, further education or training becomes unnecessary.








GSP Domains

Equivalence Process



- Initial application
- Administrative checks and approval to continue
- Portfolio submission (within 6 months)
- Assessment of portfolio
- Panel decision to progress to interview
- Interview (STP only)
- Panel decision, outcome judgement, feedback
- Ratification
- HCPC notified of outcome
- Certificates available to download by successful candidates







Domain 3 Clinical Practice	Location of evidence

Administrative checks



Registration administrator checks initial application to confirm:

- Identity of applicant
- Current Disclosure and Barring Service check at the basic level or above
- Sufficient language skills
- Size of portfolio
- Appropriate length of professional experience
- Certificates of qualifications submitted

The administrator does not review scientific content

If rejected at initial application - fees are refundable less an admin fee





Assessment Panel



Three assessors

- One specialist
- One clinical (from same Division)
- One lay chairs the interview





Portfolio assessment outcomes



There are three possible outcomes:

- Progress to interview
- > Further evidence is required
- > Reject application





Interview assessment



- Ensures the integrity of the portfolio
- Normally via video-conferencing using GoToMeeting
- Three assessors (2 professional, 1 lay chair), 1 from specialism
- Structured questions designed around GSP domains
- Normally two questions per domain
- Usually lasts between 30 minutes to one hour.





Assessment outcomes



There are three possible outcomes:

- Outcome 1: Applicant has demonstrated equivalence and can be awarded the Certificate of Equivalence
- Outcome 2: Applicant may be able to demonstrate equivalence, but further evidence is required
- Outcome 3: Applicant has not demonstrated equivalence

 - Examiner from specialism, Clinical Scientist in other field, Lay Examiner and Representative from AHCS
- 7th April 2018 Email confirming successful assessment from AHCS application to HCPC for registration as a Clinical Scientist
- 26th April 2018 HCPC Registration
